ORDER

As per the G.O read above Government have finalized the disciplinary action initiated against Shri.S.Sreejith,IPS, the then Deputy Inspector General of Police with a 'stern warning' and was cautioned not to repeat such activities.

2. The Ministry of Home Affairs, Government of India in the letter read as 3rd paper above has invited attention to the guidelines stipulated in DP&AR letter read as 1st paper above. It has been informed that as per the aforesaid guidelines after the conclusion of the departmental enquiry, if the disciplinary authority finds that some blame attaches to the officer concerned which necessitates cognizance of such fact, the Charge/officer should be awarded one of the recognized statutory penalties. On the other hand if the disciplinary authority is of the view that not to award any penalty even "Censure", then no recordable warning or reprimand should be issued against him. In view of the above guidelines Ministry of Home Affairs, Government of India has requested to revise the order read as 1st paper above.

3. Government have examined the matter in detail and hereby modifies the G.O read above by withdrawing the 'stern warning' imposed against the officer and the disciplinary action initiated against him is finalized with no recordable warning.

4. The G.O read above stands modified to that extent.


