ORDER

Based on the recommendation of the Civil Service Board meeting held on 27.05.2017, Government are pleased to order the following transfer and postings of officers in the Principal Chief Conservator of Forests, Additional Principal Chief Conservator of Forests, Chief Conservator of Forests, Deputy Conservator of Forests Grade and also the posting of the officers inducted into IFS from Select List for the years 2013 and 2014 with immediate effect.
