ORDER

As per the Government Order read as 1<sup>st</sup> paper above, IPS officers of 1986 batch were promoted to the grade of Director General of Police by creating four temporary posts in the grade of DGP with scale of pay of Rs 75500-80000 (pre-revised) for a period of two years invoking 2<sup>nd</sup> proviso to Rule 4(2) of the IPS (Cadre) Rules, 1954 and these posts were declared equivalent in status and responsibility to the cadre post of Director, Vigilance & Anti-Corruption Bureau under Rule 11 of IPS (Pay) Rules, 2007. In addition to the 4 IPS Officers of 1986 batch holding various posts under the State Government, Dr.Nirmal Chandra Asthana IPS (KL:1986), who was on central deputation as Inspector General of Police, CRPF, Delhi, was also promoted to the grade of Director General of Police on proforma basis.

2. As per Government Order read as 2<sup>nd</sup> paper above, on repatriation from central deputation, Dr.N.C.Asthana IPS was posted against the revived ex-cadre post of Additional Director General of Police (Modernisation) in the grade of Director General of Police and attached to the Kerala House, New Delhi as Officer on Special Duty.

3. Consequent on the retirement of Dr.T.P.Senkumar IPS, DGP & State Police Chief on 30.6.2017, a vacancy in the cadre post of DGP emerged w.e.f 01.07.2017. In the circumstances, Dr.Nirmal Chandra Asthana IPS (KL:1986), being the senior most IPS officer of 1986 batch, is promoted as DGP on regular basis in the scale of pay Rs 205400 – 224400.

4. On promotion Dr.Nirmal Chandra Asthana IPS (KL:1986), DGP is posted as Director, Vigilance & Anti-Corruption Bureau in the existing vacancy.


