**ORDER**

The Managing Director, Kerala State Co-operative Bank Limited as per the letter read as 2<sup>nd</sup> paper above has informed that there is a liability of ₹2,66,957/- (Rupees Two Lakhs Sixty Six Thousand Nine Hundred and Fifty Seven) against Shri. E Devadasan IAS, who retired from service on superannuation on 31.03.2019, while serving as Managing Director, Kerala State Co-operative Bank Limited, on account of erroneous fixation of pay by the Accountant General (A&E) Kerala. Shri. E Devadasan IAS (Rtd), as per letter read as 3<sup>rd</sup> paper above, has given consent for recovery of the liability from his pensionary benefits.

2. Government have examined the matter in detail. On the basis of circular read above and the consent submitted by Shri. E Devadasan IAS (Rtd), Government hereby authorize Under Secretary/DDO, General Administration (Budget Wing) Department to draw ₹2,66,957/- (Rupees Two Lakhs Sixty Six Thousand Nine Hundred and Fifty Seven only) from the DCRG of Shri. E Devadasan IAS(Rtd) as recovery towards Non Governmental dues, after getting authorisation from the Accountant General and to remit the amount to Kerala State Co-operative Bank Limited through Demand Draft/Pay order in favour of Kerala State Co-operative Bank payable at Thiruvananthapuram, The amount shall be drawn from the Secretariat Sub Treasury.
