ORDER

Shri.A.V.George IPS(KL:2004), the then District Police Chief,Ernakulam (Rural) has been placed under suspension vide Government Order read as 2<sup>nd</sup> paper above in connection with the case relating to the death of one Sreejith at Varappuzha, under Rule 3 of All India Services (Discipline & Appeal) Rules, 1969 against contemplated disciplinary action on the basis of the report of Director General of Police & the State Police Chief read as 1<sup>st</sup> paper above. Articles of Charges and Statement of Imputations read as 3<sup>rd</sup> paper above were issued on him.

2. Government have extended the period of suspension of Shri.A.V.George IPS for a further period of thirty days with effect from 10.06.2018, vide Government Order read as 4<sup>th</sup> paper above to pursue the disciplinary action contemplated against him.

3. As provided under Rule 3(8)(d) of All India Services (Discipline & Appeal) Rules, 1969, where no order has been passed under this clause, the order of suspension shall stand revoked with effect from the date of expiry of the order being reviewed.

4.Government have examined the matter in detail and are pleased to reinstate Shri.A.V.George IPS(KL:2004) into service without prejudice to the departmental proceedings going on against him.

5.On reinstatement Shri.A.V.George IPS is posted as Superintendent of Police, SBCID(Intelligence), Thiruvananthapuram.
