ORDER

Government are pleased to accord sanction for the deputation of Shri.S. Vysak IFS, (KL:2015), Assistant Deputy Conservator of Forests, Office of the Divisional Forest Officer, Malayattoor for undergoing XXXX PG Diploma Course in Advanced Wildlife Management for the period from 01.09.2018 – 30.06.2019 at Wild Life Institute of India, Dehradun as a special case in relaxation to the conditions in the Circular read as 1st paper above. A post of Assistant Deputy Conservator of Forests in the Forest Headquarters should be kept vacant during the period of his training in order to pay the salary of the officer during the training period.

2. The period of training and transit of Shri. S. Vysak IFS will be treated as duty under Rule 12(7) (iii) of Part I, Kerala Service Rules. During the period of the deputation, the officer will be entitled to his pay and allowances, he would have drawn but for the deputation and the expenditure on this account will be met from the Head of Account 2406-01-001-99-00-01-0 MAJ-SMJ-MIN-SUB-SFUB. The State Government

will not bear the expenditure of Rs.10,00,000/-(Rupees Ten Lakhs only) towards the course fee which includes the expenses for boarding & lodging for the entire duration of the courses as well to and fro travel fare (while joining the course in WII and returning from place of posting in the parent department) as per WII TA Rules, field tours, field equipment, camping gear, resource materials etc during the training.

3. Shri. S. Vysak IFS shall execute a bond as appended to this Government Order to the Principal Chief Conservator of Forests & Head of Forest Force before proceeding for training.

FORMAT OF BOND TO BE EXECUTED BY A GOVERNMENT SERVANT BEFORE
PROCEEDING FOR POST GRADUATE DIPLOMA COURSE IN ADVANCED WILDLIFE
MANAGEMENT OF WILDLIFE INSTITUTE OF INDIA 2018-2019

KNOW ALL MEN BY THESE PRESENTS THAT I,,
, resident of, at
present employed as in the Ministry/Department
....., do hereby bind myself and my heirs, executors
and administrators to pay to the President of India (hereinafter called the
'Government') on demand, 'all charges and expenses' that shall or may have been
incurred by the Government for my training by Wildlife Institute of India i.e. all
money's paid to me or expended on my account during training such as pay and
allowances, leave salary, cost of fee, travelling and other expenses, cost of
international travel and cost of training abroad met by the Government/Agency
concerned, etc., being conducted by Wildlife Institute of India together with interest
thereon from the date of demand at Government rates, for the time being in force,
on Government loans or, if payment is made in a country other than India, the
equivalent of the said amount in currency of that country converted at the official
rate of exchange between that country and India and together with all costs
between the attorney and the client.

WHEREAS I,, am being deputed for Post Graduate
Diploma Course in Advanced Wildlife Management by the Wildlife Institute of India.

AND WHEREAS for the better protection of the Government I have agreed to
execute this bond with such conditions as written hereunder:

NOW THE CONDITION OF THE ABOVE WRITTEN OBLIGATION IS THAT, in the
event of my failing to resume duty, or resigning or retiring from service or otherwise
quitting service, without returning to duty after expiry or termination of the period
of training, OR failing to complete the training programme, OR quitting the service at
any time within a period of 10 months after my return to duty, I shall forthwith pay
to the Government or as may be directed by the Government, on demand the said
sum together with interest thereon from the date of demand at Government rates
for the time being in force of Government loans.

AND upon my making such payment the above written obligations shall be void

and of no effect, otherwise it shall be and remain in full force and virtue.

The Bond shall in all respects be governed by the laws of India for the time being in force and the rights and liabilities hereunder shall, where necessary, be accordingly determined by the appropriate Courts of India.

The Government of India has agree to bear the stamp duty payable on this bond.
