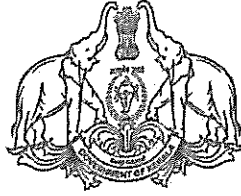

IPS – Promotion of Shri Navneet Sharma IPS and Shri Ilango.R IPS to the grade of Senior Time Scale with retrospective effect- Orders issued

ORDER

As per Government Order read as 1st paper above, Smt. Chaitra Teresa John IPS and Shri Sujith Das IPS, who belong to the 2015 RR batch of Indian Police Service of Kerala cadre, were promoted to the Senior Time Scale of Indian Police Service with effect from 01.01.2019. However, Shri Navneet Sharma IPS and Shri Ilango.R IPS of the same batch were not promoted to Senior Time Scale as they had availed extra-ordinary leave during their training period and as a result they did not possess the mandatory four years of service required to be eligible to be considered for promotion to the Senior Time Scale as per Rule 3 of All India Service (Pay) Rules, 2016. Subsequently, as per Government Order read as 2nd paper above, Shri Navneet Sharma IPS and Shri Ilango.R IPS were promoted to the Senior Time Scale with effect from 01.01.2020.

2. As per letters read as 3rd paper above, the State Police Chief requested Government to grant promotion to Shri Navneet Sharma IPS and Shri Ilango.R IPS with retrospective effect from 01.01.2019 as they belong to the 2015 batch of regular recruits and also since their batch-mates had already been promoted to the Senior Time Scale with effect from 01.01.2019, by treating the period of extra-ordinary leave availed by these officers during their training period as leave taken for a cause beyond the control of the members of Service and by treating the leave period as a completed year of service as stated under Note 3 of Rule 3 of IPS (Pay) Rules, 2016. The members of Service too submitted representations to Government as per references read as 4th and 5th papers above for their promotion to Senior Time Scale with retrospective effect from 01.01.2019.

3. Government examined the proposal of the State Police Chief, Kerala and the representations from the members of Service and are pleased to order promotion of Shri Navneet Sharma IPS (KL:2015) and Shri Ilango.R IPS (KL:2015) to Senior Time Scale with retrospective effect from 01.01.2019, by treating the period of extra-ordinary leave availed by these officers as leave taken for any cause beyond their control, as stipulated under Note 3 of Rule 3 of IPS (Pay) Rules, 2016. For this purpose, Shri Navneet Sharma IPS and Shri Ilango.R IPS are deemed to have been posted to the cadre posts of the Assistant Director, KEPA and Assistant Director, KEPA (Admin) respectively during the period from 01.01.2019 to 31.12.2019.
