ORDER

The Ministry of Home Affairs, as per the letter read as 1st paper above, had conveyed the approval of the Competent Authority for the induction of Shri. Prateesh Kumar IPS (KL:2011) into Intelligence Bureau (IB) to the post of Joint Deputy Director (SP level) on deputation basis for an initial tenure of four years from the date of assumption of charge of the post or until further orders, whichever event takes place earlier, and had requested to relieve the officer to take up the new assignment at the Centre immediately.

As per Government letter read as 2nd paper above, the Ministry of Home Affairs were informed that the officer was on deputation from the cadre to attend the Phase-III Mid Career Training Programme for IPS officers scheduled at Sardar Vallabhbhai Patel National Police Academy, Hyderabad from 03.02.2020 to 28.02.2020 and he would be relieved for Central deputation on his reporting back to the cadre after completing the aforementioned training programme. The officer has now reported back to the cadre upon completion of the mandatory Phase-III MCTP.

3. In the circumstances, Shri. Prateesh Kumar IPS (KL:2011), Superintendent of Police (Headquarters) is relieved off his duties from the State Cadre to take up his new assignment as Joint Deputy Director (SP level) in the Intelligence Bureau (IB) on Central deputation basis for an initial tenure of four years from the date of assumption of charge of the post or until further orders, whichever event takes place earlier.
