As per the letter read as 5th paper above, the State Police Chief has reported that due to the recent Corona Virus issue and the volcanic eruption near Manila the above conference has been shifted to 16th & 17th March 2020 under the new title "Global Resolve Against the Online Sexual Exploitation of Children Conference" and also requested to grant permission to Sri.Manoj Abraham IPS to attend the same.

Government have examined the matter in detail and are pleased to accord sanction to Sri.Manoj Abraham IPS, Additional Director General of Police, Headquarters to attend the South East Asia Regional Conference on "Global Resolve Against the Online Sexual Exploitation of Children Conference" scheduled to be held on 16th & 17th March 2020 in Manila, Philippines.
