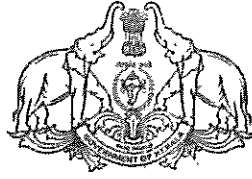

ORDER

As per Government Order read as 2<sup>nd</sup> paper above Shri. Narendra Babu.S IFS(KL:2012) and as per Government order read as 3<sup>rd</sup> paper above Shri. Patil Suyog Subhash Rao IFS and Smt. R. Keerthi IFS of 2012 batch and Shri. Samuel Vanlalngheta Pachuau IFS of 2013 batch were granted promotion to Senior Time Scale of IFS from the date of the respective Government orders.

2) Shri. Narendra Babu.S IFS (KL:2012) , Shri. Patil Suyog Subhash Rao IFS (KL:2012) and Smt. R. Keerthi IFS (KL:2012) were confirmed in service on 03.09.2014 and Shri. Samuel Vanlalngheta Pachuau IFS (KL:2013) was confirmed on 02.09.2015. Therefore , as per representations read as 4<sup>th</sup> to 6<sup>th</sup> papers above Shri. Patil Suyog Subhash Rao IFS, Smt. R. Keerthi IFS and Shri. Samuel Vanlalngheta Pachuau IFS requested Government to give retrospective effect to the promotion granted to them to Senior Time Scale. Head of Forest Force as per letters read as 7<sup>th</sup> paper above recommended their request.

3) The guidelines regarding promotion of members of IFS states that an Officer is eligible for appointment to the Senior Time Scale on completion of service of 4 years service subject to availability of posts, and this scale can be allowed from or after 1<sup>st</sup> January during the relevant year in which the officers become eligible for this scale.

4) In the circumstance Government have examined the matter and are pleased to give retrospective effect to the promotion granted to the officers to senior Time Scale as detailed below.

Patil Suyog Subhash Rao IFS (KL:2012)	01.01.2016	The additional charge of Divisional Forest Officer, Konni held by him for the period from 30.12.2015 to 26.01.2016 and for the period from 01.12.2016 to 14.12.2016 is treated as full charge. The additional charge of Divisional Forest officer, Thrissur held by him for the period from 19.12.2016 to 15.02.2018 is also treated as full charge.
			He is deemed to have been posted to the cadre post of Deputy Conservator of Forests (Wildlife) for the period from 27.01.2016 to 30.11.2016.
3	Smt.R. Keerthi (KL:2012)	01.01.2016	She is deemed to have been posted to the cadre post of Deputy Conservator of Forests (Administration) for the period from 01.01.2016 to 09.06.2016. The additional charge of Divisional Forest Officer, Chalakkudy held by her for the period from 10.06.2016 to 15.02.2018 is treated as full charge.
4	Shri. Samuel Vanlalngheta Pachuau IFS (KL:2013)	01.01.2017	The additional charge of Divisional Forest Officer, Palakkad held by him for the period from 09.12.2016 to 22.11.2017 and the additional charge of Deputy Conservator of Forests & Wildlife Warden, Silent Valley held by him for the period from 23.11.2017 to 15.02.2018 are treated as full charge.
